Steveston Farmers & Artisans Market - Rules and Regulations for Entertainers

The Steveston Farmers and Artisans Market (SFAM) is responsible for the location and size of stage & entertainment area and will provide a tent or tents, table, chairs, power cords and power.

Performers must supply their own equipment such as microphone, amp, speakers, intermission music.

Performers are responsible for securing and paying to park their vehicles.

Performers must check in with the market manager upon arrival no later than 11:00 a.m. and are required to stay at the market until 3:00 p.m. There will be 2 breaks during the day, each one lasting no more than 30 minutes.

SFAM is an outdoor market and is held rain or shine. Performers are expected to attend on their appointed dates regardless of weather conditions.

Performances should be geared towards a family-based audience.

In consideration of market vendors and the guests, performers are NOT permitted to use amplification devices without prior approval.

Performers will only perform in the designated areas and may be asked to move during the market.

Entertainment is intended to enhance the market environment and should not interfere with vendor/guests transactions.

Performers shall agree to abide by decisions of the market managers.

If a performer is unable to attend the market on their scheduled date, they must advise the market manager no later than 5:00 p.m. the Wednesday prior to the market date by calling the market phone at 604.729.7326.
